PAYMENT

FamousOwnedBullies only accepts cash, money orders, wire transfers, cashier’s checks or PayPal (+3%). All transactions must clear prior to the pickup/delivery of said Puppy.

SHIPPING

Buyer is responsible for the shipping of said Puppy. The cost of shipping includes, but is not limited to, airline tickets, airline approved shipping crate, and a health/veterinary certificate. Shipping dates are tentative and subject to change due to weather, flight availability, etc. Once said puppy has been delivered to the departing airport, FamousOwnedBullies is no longer responsible for its safety, health, or wellbeing. FamousOwnedBullies is also no longer

responsible is said Puppy is lost or stolen. Buyer understands that it is their choice to have said Puppy shipped, and take sole responsibility for any issues that should arise during or after shipping. FamousOwnedBullies is not liable for said Puppy after it has left the direct care of FamousOwnedBullies.

██████████ All puppies MUST BE AT LEAST 8 WEEKS OF AGE before they can leave to a new home.

BUYER AGREEMENT

██████████ Buyer agrees to have said Puppy examined by a licensed veterinarian within 2 days of said Puppy's arrival into their home and inform FamousOwnedBullies immediately of the examination results by email, fax or phone. If said Puppy is found to have a life threatening congenital defect or health problem in the health exam given within the first 5 days of ownership, Buyer is required to contact FamousOwnedBullies within 24 hours of the exam with a signed statement of diagnosis of a life threatening condition from a licensed veterinarian. If these steps are followed, a replacement puppy or a refund of the initial purchase price may be given.

Said puppy must be returned immediately. FamousOwnedBullies will get a second opinion from their choice of a licensed veterinarian. Whether a refund or replacement puppy will be given is at the discretion of FamousOwnedBullies.

Shipping costs for the return of said Puppy to FamousOwnedBullies will be at Buyer's expense. All documents given at the time of purchase must be returned with said Puppy.

FamousOwnedBullies is not liable for any common illness or health condition that may occur or is diagnosed after this initial 48 hour period.

██████████ Buyer agrees to provide said Puppy with routine preventative care such as, but not limited to, annual examinations by a licensed veterinarian and following veterinarian guidelines for vaccinations, de-worming, flea and heartworm preventatives.

██████████ Buyer understands that this breed is prone to health problems. Buyer understands they are responsible for any/all veterinary bills accrued once said Puppy has left the possession of FamousOwnedBullies.

If at any time during the life of said Puppy Buyer decides due to unforeseen circumstances they cannot continue to care for said Puppy they may return said Puppy to FamousOwnedBullies and FamousOwnedBullies will find a suitable home. No refund of any kind will be given.

GUARANTEE

FamousOwnedBullies guarantees that said Puppy is believed to be healthy at the time of sale and has received age appropriate vaccinations and de-worming. FamousOwnedBullies has made every effort to provide you with a healthy, quality puppy.

Said Puppy is considered “Pet Quality.” FamousOwnedBullies offers no guarantee that said Puppy could or could not have faults, which could make said Puppy unsuitable for showing or breeding.

FamousOwnedBullies does not guarantee size, temperament, conformation or color when said Puppy is mature.

Said Puppy is guaranteed for one year from the date of birth against fatal or life altering congenital diseases, which adversely affect the overall health of said Puppy. This includes hip dysplasia that requires surgery to correct, kidney, heart, pancreas, spine or liver problems of a severe and life altering nature. Any physical problem, which is or could be the result of injury, is not included in this guarantee. This guarantee applies to Buyer on this agreement only and is nontransferable to a second party.

This guarantee only covers congenital defects, and does not include any condition that may have been caused by environmental factors (allergies, thyroid dysfunction, autoimmune disorders, skin tags, or benign tumors) or any common illness/condition. If said Puppy is found to have a life-threatening congenital defect or health problem diagnosed within two years of said Puppy’s birth date, Buyer is required to contact FamousOwnedBullies within 48 hours of the exam(s) with two signed statements of the same diagnosis of a congenital life threatening condition from two unassociated, licensed veterinarians. If these steps are followed, and upon the return of said Puppy, FamousOwnedBullies may provide a replacement puppy.

No replacement puppy will be given if said Puppy has been bred, spayed, neutered or euthanized without prior written approval from FamousOwnedBullies.

Any replacement puppy will be agreed upon by both parties and will be of comparable quality and price. It is understood that the replacement puppy may not be immediately available.

If said Puppy dies within one year from the date of birth, Buyer will pay for an autopsy to ascertain the cause of death. Only if the cause of death is congenital, FamousOwnedBullies may replace said Puppy with a puppy of equal value from the next available litter.

 FamousOwnedBullies does not guarantee against any common bulldog health problems such as cherry eye, hernias, entropion, loose hips, allergies, elongated soft palate, stenotic nares (collapsed nostrils) or demodectic mange.

FamousOwnedBullies does not guarantee against Parvo, Distemper or Corona Virus as these are highly contagious diseases and can be transmitted immediately after leaving FamousOwnedBullies.

FamousOwnedBullies does not guarantee against conditions that may or may not be stress related due to the move to a new home or the shipping process. Some stress related conditions that have previously remained dormant can be triggered by the aforementioned scenarios and may not be diagnosed immediately. Some examples of these non-guaranteed stress related illnesses/conditions are, but are not limited to, hypoglycemia (low blood sugar), Coccidiosis, Giardia, Bordatella (or any form of Kennel Cough), and worms. These can be caused by the living conditions of said Puppy. Coccidia is a bacterial infection brought on by stress and/or diet change. Giardia is an infection brought on by infected drinking water. Worms recycle often and it is very important to maintain a routine de-worming program. Kennel Cough is self-limiting and like the common cold, it must run its course. Full recovery is expected and Kennel Cough on its own is not life threatening. All of these conditions are treatable by a veterinarian.

 Buyer is aware that owning a puppy requires routine and sometimes unexpected trips to a veterinarian and understands that Buyer will be responsible for all payment/bills.

Buyer has been informed of the vaccinations said Puppy has received and also is aware of the due dates for further vaccinations and de-worming required.

By signing below, Buyer and FamousOwnedBullies agree that they have read and understand this contract in its entirety. It is agreed that any legal issues concerning said Puppy will be handled in a court of law in San Diego, California. This extends to internet sales across state lines. This contract supersedes any and all previous agreements. No verbal agreements will be upheld. Buyer understands if the terms and conditions of this contract are not fulfilled the result will be at the discretion of FamousOwnedBullies.
